I (we) agree to all Credit Terms and Conditions: In consideration of the extension of credit by Mid-West Fertilizer, Inc. (MWF): 1) All credit extensions are for approved accounts only, otherwise all sales are cash; 2) An account is considered delinquent after the 10<sup>th</sup> of the month following the month of purchase; 3) Unpaid balances after the 10<sup>th</sup> of the month following the month of purchase are subject to a 1.5% service charge per month (18% annually or maximum allowable in applicable territory); 4) Any account exceeding the given credit limit or is outstanding past terms will be placed on COD; 5) Should this account upon default be collected by or through an attorney-at-law or any other collection efforts, the undersigned agrees to pay reasonable attorney's fees or collection fees in addition to the principle indebtedness and interest thereon; 6) All sales will be billed the date of pickup, delivery or for services rendered; 7) Tenants will be expected to pay for said inventory or services, if landlords or partners do not have approved credit; 8) I (we) understand that it is a part of MWF's sales documentation policy that all deliveries are signed for by the customer to verify receipt of the items purchased. I (We) also acknowledge that it is not always possible to be present when MWF makes the deliveries.
